A CIBA Voting Member is a person over the age of 18, who is of California Indian descent, and practices traditional California Indian basketry.

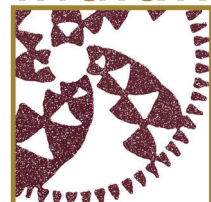
